**The Healthy Homes for Healthy Kids program offers comprehensive environmental assessments for low-income households with at-risk children. The assessment is followed by the development of a family-centered action plan and then the delivery of tailored education, referral and/or intervention. Lead poisoning and asthma management are the leading reasons for service. Additional items addressed are fire safety, radon, carbon monoxide and natural gas leaks, pest management, and accidental injuries such as trips, falls, scalds, burns, poisonings, suffocation, and drowning.**

**The Childhood Lead Poisoning Prevention program works collaboratively with the local Get the Lead Out! project to educate parents, professionals, and the community about strategies to help prevent childhood lead poisoning. The program conducts outreach for the City of Grand Rapids and the State of Michigan's Lead Hazard Control programs, including case management of those in the application process.**

**The Healthy Homes Coalition's FEMA Fire Safety program is a straightforward program that provides smoke and carbon monoxide detector installations for free for households with young children.
