



FAQ's for Service Line Replacement in a Construction Zone

What is the City doing and how will it affect me?

The City of Grand Rapids will be conducting partial service line replacement, meaning that they are replacing the portion of the water service line that they own. The City owns the portion of the service line from the water main to your property line. If you would like to do full service line replacement, you are responsible for the cost from your property line to your water meter.

The replacement typically takes one business day to install, leaving you without water for less than one day. It usually does not involve digging and, if done in conjunction with roadwork, the sidewalk is not an issue.

How do I know if my service line is made of lead?

Lead was discontinued as a service line material around 1930, so most lead service lines are 85 years old or more. To find out if your service line is lead, contact Jessi Pakiela at the City of Grand Rapids at (616) 456-3041.

Should I replace my service line if it is lead?

Yes, based upon the scientific literature, the Healthy Homes Coalition recommends precaution. In other communities across the nation, partial lead service line replacement has often resulted in a short-term increase of lead content in residential water. Due to a lack of testing, it is unclear if this type of work in Grand Rapids and other west Michigan communities results in elevated lead content in the water. Since we do not know, we recommend full replacement.

How much does it cost to replace my lead service line?

The cost depends on many factors, primarily the length of the service line. Current estimates are \$1,500 - \$2,500.

What if I can't afford the complete replacement?

The City of Grand Rapids offers a 10-Pay Plan for homes with lead service lines. This is a 10-year loan with annual payments at 7% simple interest (this rate may be reduced in the future). See the attached for more information.

Additionally, if other repairs to the home are needed (such as furnace, electrical, plumbing, or roofing), you may qualify for the City's Housing Rehabilitation program which offer low and no-interest loans for home repairs. You may contact the Housing Rehabilitation program at (616) 456-3030.

You may also consult with your bank or credit union about financing.

Who will replace my lead service line?

You will need to hire a private contractor who has been approved by the City. See the attached list of plumbing and excavation companies and seek out those that do plumbing.

How do I know if my water is safe?

The EPA recommends zero parts per billion (ppb) (<https://www.epa.gov/your-drinking-water/basic-information-about-lead-drinking-water>). The CDC recommends using bottled or filtered water until your water lead level is less than 15 ppb (<http://www.ncbi.nlm.nih.gov/pubmed/21112052>). In order to know your water lead level, you must have your water tested by a qualified laboratory.

How do I get my water tested?

The Michigan Department of Health and Human Services offers water testing for \$18. See the attached for more details. The Kent County Health Department will begin testing water for lead in the near future. Visit KCHD's website for more information (<https://www.accesskent.com/Health/laboratory.htm>).

Should I use a water filter?

Yes, based upon the scientific literature, the Healthy Homes Coalition recommends using NSF International approved water filtration for two years following partial or full service line replacement or until your water tests at a level with which you are comfortable. The filter or cartridge must be labeled as NSF/ANSI 53 or NSF/ANSI 58. The initial cost is about \$50-60 plus additional filters at \$20-30 each. City of Grand Rapids 10-Pay Plan

There are 2 different programs for lead abatement loans. The Community Development office offers income-based loans for targeted areas in the City. Call 456-3030 for more information on that program.

The lead abatement program offered through our office is a 10-year loan with annual payments at 7% simple interest. The first payment is due no sooner than 30 days after your contractor submits an invoice to me. The first payment is for 1/10th of the amount without interest. Subsequent payments will be due on or around the same date each year for 1/10th of the original amount plus 7% of the remaining loan balance. This is a lien against the property. Any remaining amounts must be paid in full prior to transfer of ownership. You may make payments in between. There is no penalty for early repayment.

To qualify for this program, you must have a lead water service. All overdue amounts to the City must be paid in full – everything from taxes to parking tickets. Amounts owed are verified through the Treasurer's Office. This does not include amounts on a payment plan (like paying your water bill monthly instead of quarterly) as long as you are current for the payment cycle.

For the loan, you must provide proof of ownership and at least two written estimates from contractors registered with Utility Engineering specifically for underground water/sewer work.

The loan agreement must be signed by every listed owner and notarized at our office. Each owner will be required to provide a driver's license or state-issued ID card.

When getting estimates, be sure to let contractors know that this will be a lead abatement loan through the City. I will need a copy of the invoice to process payment. If the city side of the service is lead, the contractor must coordinate with Field Operations office to schedule replacement at our expense in conjunction with the private side replacement.

Basic steps for the loan process are:

- Notify me you would like to participate in the loan program.
- Treasurer's Office verification of eligibility. We schedule a time for you to come to 1120 Monroe, 3rd floor, and sign the agreement.
- At the appointment:
 - You will be required to provide the estimates, proof of ownership, and picture ID. I can accept the tax record as proof of ownership if the records match owner ID.
 - You select a contractor.
 - We will go over the loan contract and whether you still want to use the loan program. You may opt out of the program at any time before I receive the invoice.

- The document will be signed, witnessed, and notarized. You may bring your own witness (who must have state-issued picture ID) or someone here will act as a witness.
- You will be given a copy of the signed and notarized agreement.
- Usually the contractor likes to have someone from our office verify that the contract is signed.
- Contractor performs work, then submits the invoice to you and to our office.
- The contract and invoice are forward to the Engineer's Office and recorded at the County Register of Deeds as a lien against the property.
- The contract and invoice are forwarded to the Treasurer's Office for payment.
- Payment is mailed to you. The check is in the name of all owners and the name of the company. Owners endorse the check and bring it to the contractor so they can endorse it and deposit it.
- You will be invoiced by the Treasurer's Office annually. This will be separate from your taxes, water bill, etc.

If making additional payments during the year, be sure to specify it is for your lead abatement loan. It is best to include your specific loan number when you submit any payment.
